

## DRAFTKINGS' ONLINE SPORTSBOOK AVAILABLE AT TULALIP RESORT CASINO AND QUIL CEDA CREEK CASINO PROPERTIES

*Tulalip Resort Casino to Celebrate On-Property Mobile Sports Wagering With Former Seattle Seahawks Cornerback Richard Sherman Wednesday, April 5*

**TULALIP, Wash. (April 3, 2023)** – After celebrating the grand opening of two state-of-the-art retail DraftKings Sportsbooks at Tulalip Resort Casino and Quil Ceda Creek Casino in September 2022, both casinos have today announced an exciting mobile sports wagering option for customers on the DraftKings Sportsbook app available exclusively at their properties.

Starting April 3, eligible customers interested in placing bets on the DraftKings Sportsbook app can wager from their mobile devices while on property at the Tulalip Resort Casino and Quil Ceda Creek Casino.

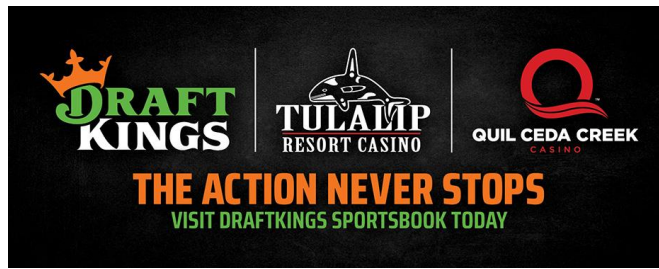
Customers will be required to download the DraftKings Sportsbook [app](#), create an account and register in person with a valid state-issued ID by visiting the retail sportsbooks located at Tulalip Resort Casino or Quil Ceda Creek Casino. Once the DraftKings Sportsbook account has been verified, customers will be able to place wagers from their phone or tablet across various sporting events and professional sports leagues such as MLB, NHL, NBA, NFL and more – anywhere within the casinos, resort or parking areas.

To help celebrate the launch of on-premise mobile sports betting at Tulalip Resort Casino and Quil Ceda Creek Casino, former Seattle Seahawks' All-Pro cornerback and football analyst on *Thursday Night Football on Prime Video* Richard Sherman, will host a meet-and-greet with fans Wednesday, April 5, at the retail DraftKings Sportsbook located at the Tulalip Resort Casino from 11a.m. to 1p.m. Due to his limited appearance, there will not be an opportunity for autographs.

Since opening the DraftKings Sportsbooks at both casinos in September, sports fans have been able to enjoy an enhanced sports viewing experience. Customers at **Tulalip Resort Casino's** 5,005-square-foot DraftKings Sportsbook can watch up to 10 live sporting events on an impressive LED television screen spanning more than 800-square-feet while placing bets at 30 kiosks and four over-the-counter ticket windows.

The DraftKings Sportsbook at **Quil Ceda Creek Casino** features 19 sports betting kiosks and three over-the-counter ticket windows located on the gaming floor and at "The Stage," Quil Ceda Creek Casino's entertainment venue and nightclub. The four video walls in The Stage span a total of 896-square-feet, comprised of 13 million pixels, which can display up to 10 different views simultaneously.

The DraftKings Sportsbook at Tulalip Resort Casino includes betting resources including odds boards, scrolling tickers with live score updates and more.
